1. Reference the attached letters from [redacted] and [redacted] requesting information on their observations of 13 and 19 July 1965.

2. The objects which they observed on the nights of 13 and 19 July 1965 are similar to observations of satellites. The inconsistencies in flight can be attributed to conditions in the atmosphere and illusion of the satellite's appearance as it nears stars or other lights in the sky.

3. The objects were not ECHO I or II, PEGASUS I or II. These are the only four satellites on which we have schedules. However, there are over thirty satellites visible to the unaided eye and six are as bright or brighter than ECHO I. Identification of the satellites might possibly be obtained from either the Smithsonian Institute or from NASA.
