Message from SAC received 10450 Z reports that the Sheriff of Boise, Idaho, called Mountain Home AFB to report that 2 large red ~~flaming~~ balls were seen by several reliable witnesses.

Witnesses reported the balls seemed to be landing - instead of falling - because of a gradual movement downward and flames shooting downward. Landing area was reported as 10-12 miles NW of Boise. Sheriff's ^{men} and SAC officers will check the landing area in the morning.

SEVERAL RELIABLE WITNESSES.
WITNESSES REPORTED THE BALLS SEEMED
TO BE LANDING - INSTEAD OF FALLING -
BECAUSE OF A GRADUAL MOVEMENT
DOWNWARD AND FLAMES SHOOTING
