Dear Sir:

On Thursday 26 May, while sitting at my picture window at our small farm home, I heard the noise of a heavy plane passing aloft. The hour was about five p.m.

In about something like five minutes or thereabouts, I observed, moving towards us, over the Naples Gorge, what appeared to be a fish-bowl-like sphere, except that it had a glassy appearance. It came towards our side of the Gorge, with a sort of apparent tumbling motion. Beneath this sphere, there appeared, some small distance ahead, also glinting and gleaming in the sun, another, and a smaller sphere. Something about this unreal sort of apparition alerted me, and I found my field glasses, to look for more.

Going outside, I looked in vain for the spheres. None were in sight. Due to a bright sun, I felt perhaps they would not be visible anyway, as they were moving toward the sun.

Soon, a small plane, seeming to my untutored eye to be a private sea-plane (someone on Canandaigua Lake, used to own one) moved over our area. Within a few moments, the small plane having passed very close to Earth, I observed again, two small spheres, much the size of an orange. These seemed to sort of revolve down, into the old vineyard. Not moving on the wind. Later, when the wind came up, and seemingly pushed by the wind, appeared two sort of flat, shiny things, which dropped into the vineyard. My feeling was, that whatever they were, they were developed to diminish in size, or, to disappear either with heat, or with the dampness of the ground. I wondered if they could contain harmful spores, or even of eggs of some harmful insectae. In any event, it seems proper as a loyal citizen, to report these findings, to several agencies. This I have done. I am wondering, however, if gasoline used by planes, could either in heat or cold, drop such spheres, which disappear when closer to the Earth.

There is no need to inform anyone, as to our great confidence in the Pentagon. In these troubled times of stress, and tension, we must all be on guard on behalf of our Country.

Could it be possible that if there is anything suspect in this, that the seaplane timed it's trip, covered by the noise of the heavy, noisy, laboring plane aloft above it, ahead by some distance.

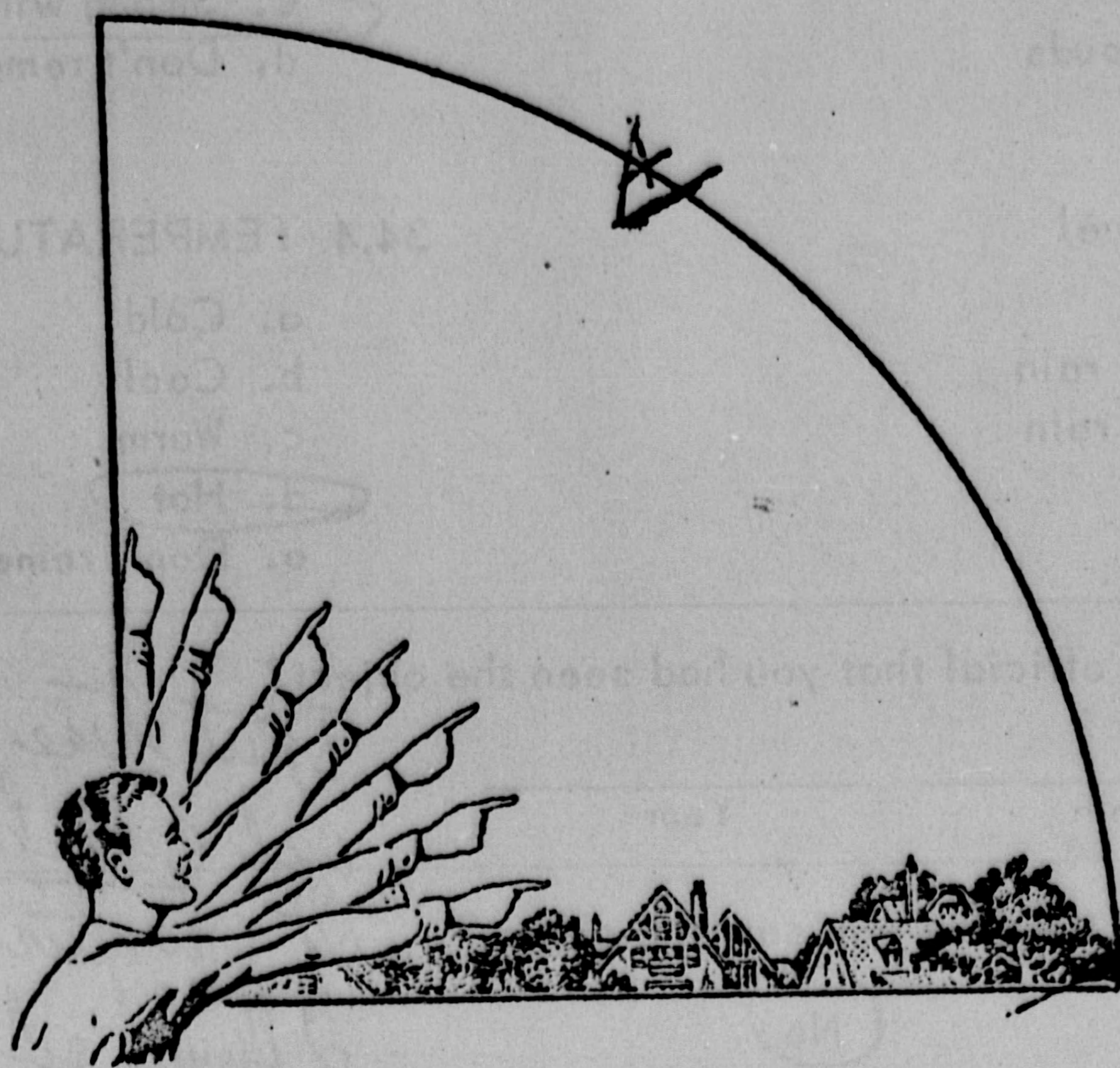

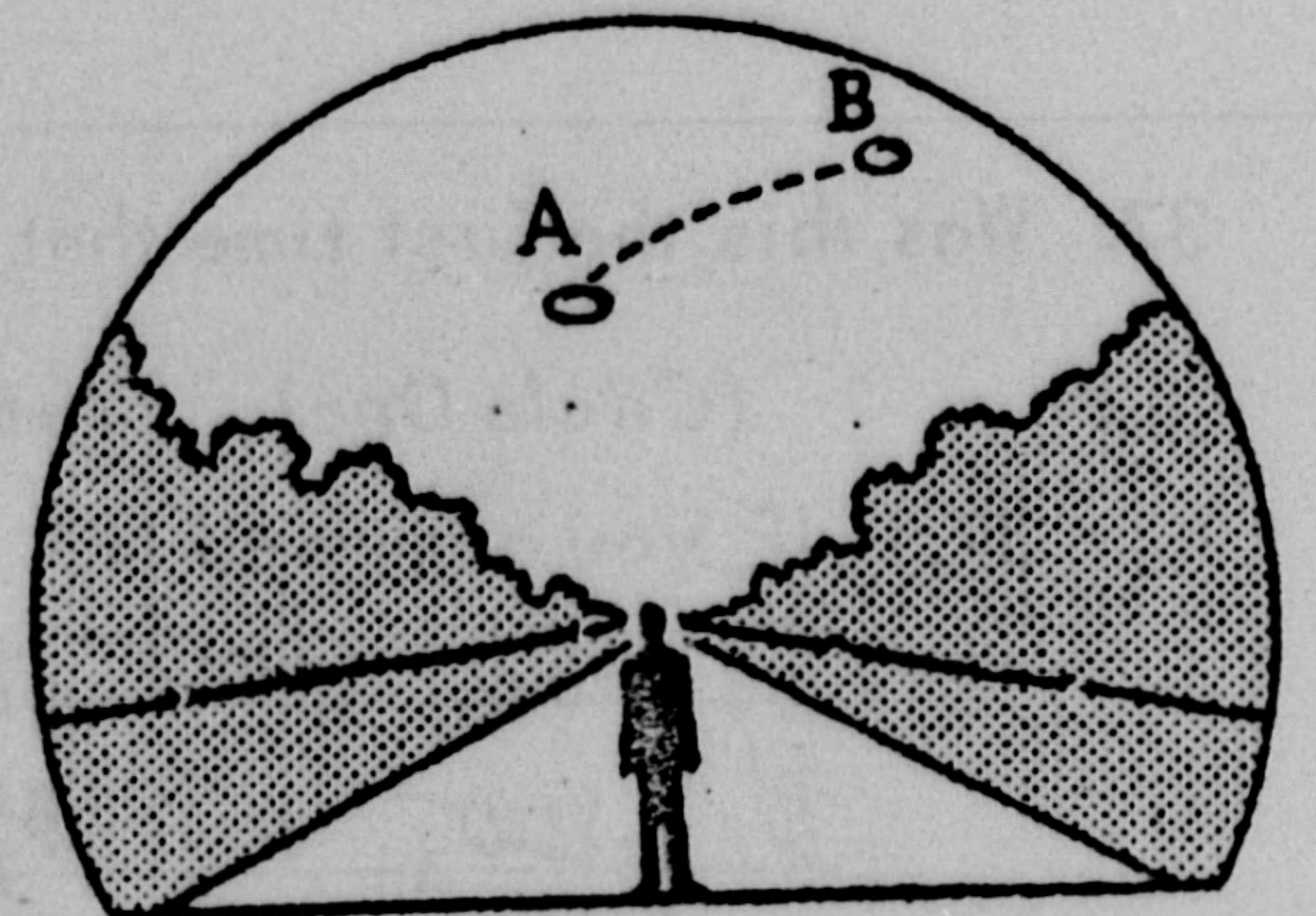
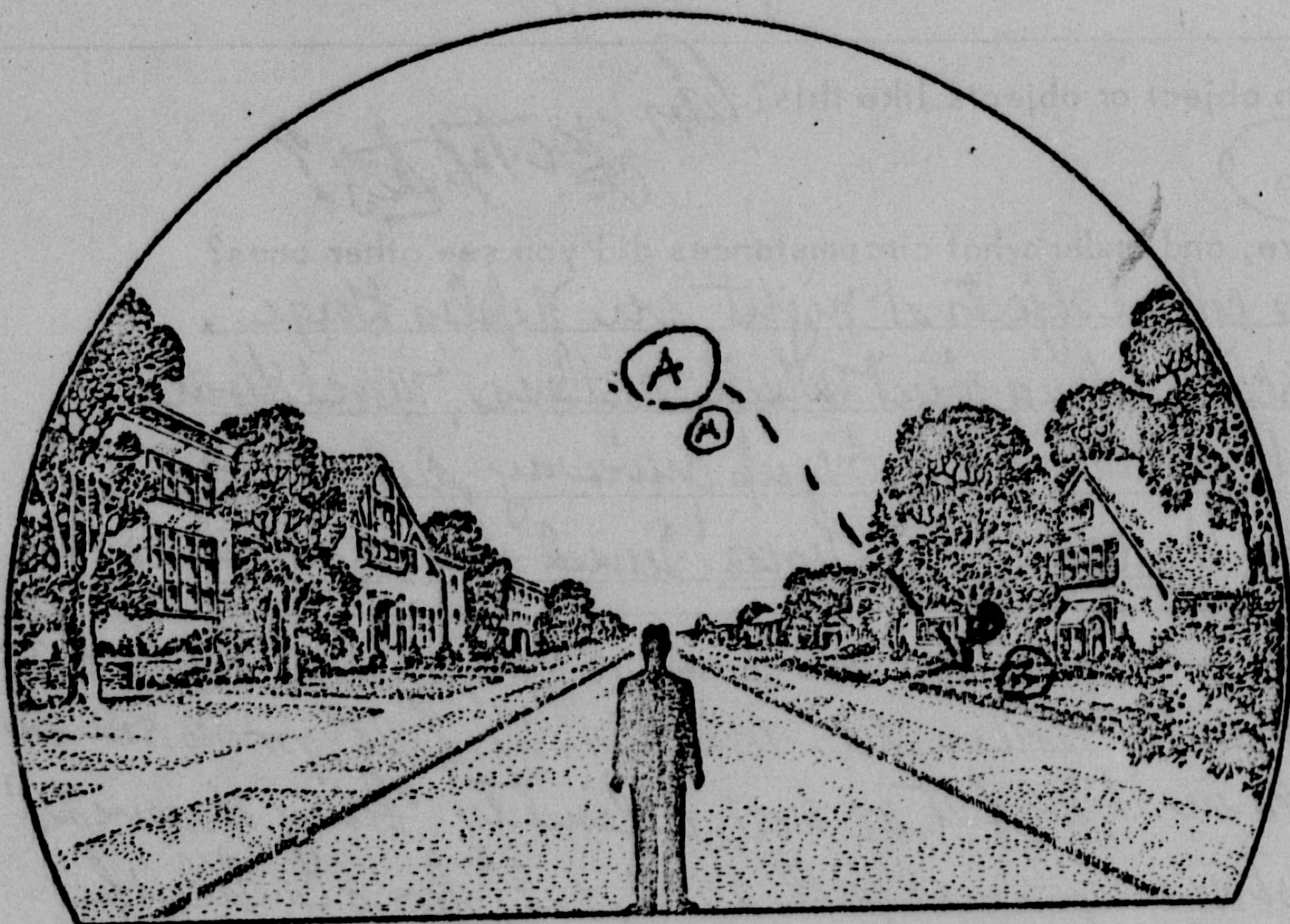
38. In your opinion what do you think the object was and what might have caused it?
