Objt stopped, turned around, orbited about 3 min, above 1000' peaks ahead of observers auto, then slowly descended behind peaks. Descended apparently straight down.		11. COMMENTS Saw plane in rear view mirror while driving along mountain road. Plane came near car and shot flare at about this time and continued circling and disappeared behind mountains. At about same time radiator of car boiled over and car stopped due to overheating, fan belt was off causing water pump to not function as well as limit generator action while loose causing flickering of car lights. All this plus the alcohol pulls the coincidence of the plane and flare created the UFO situation in the observers' mind. Very good investigation of surrounding data by intelligence team.
