Dear Sir,

If you cannot readily explain by tanker refuelling or controlled JCBM activity, I feel you will be interested in this report of an otherwise unexplainable sighting of a UFO.

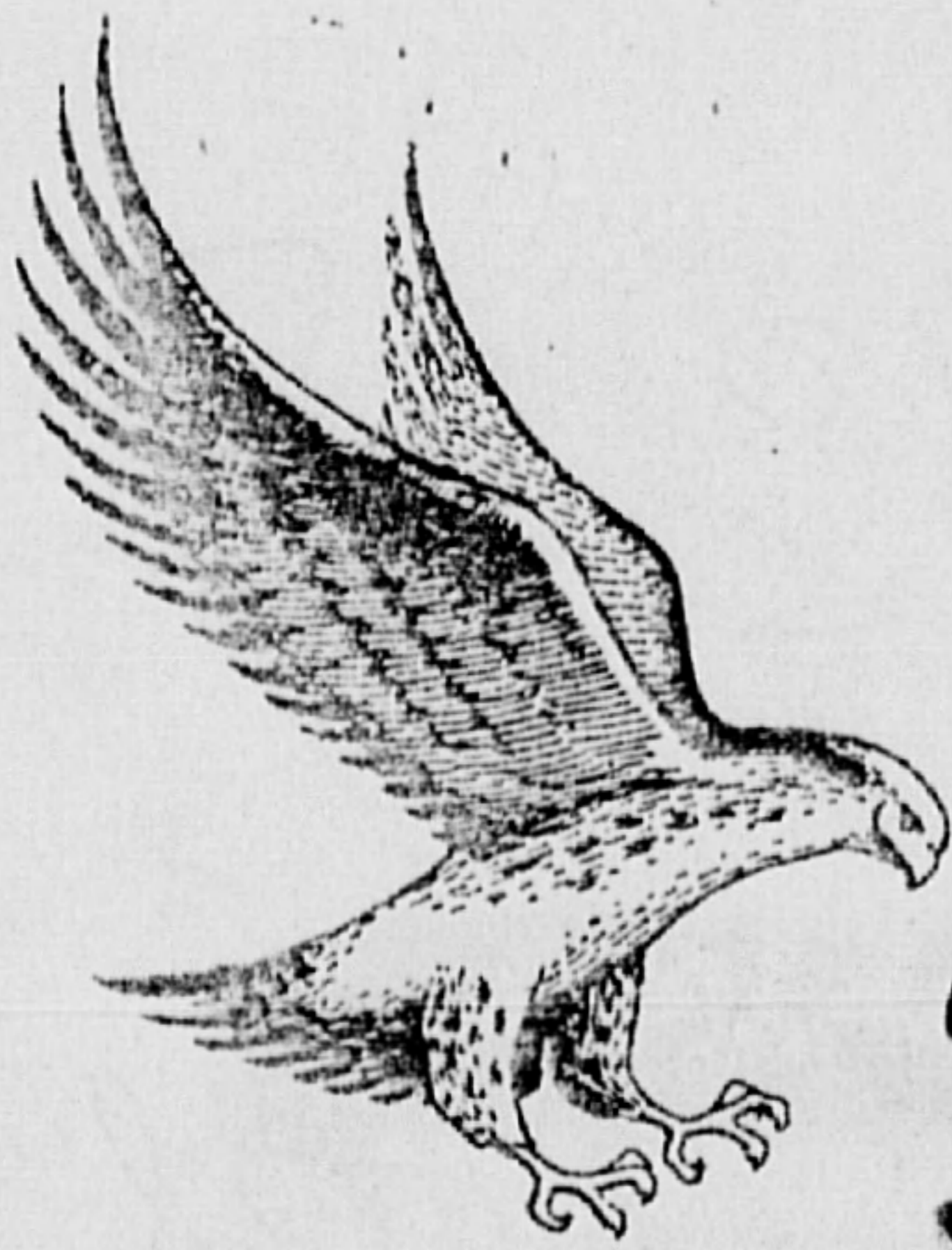
At 01⁰⁷ Z on the evening of July 9th., [REDACTED] on the North Coast of Jamaica drew the attention of myself and my First Officer [REDACTED] to a strange light in the North. The sky was completely clear of cloud, and the stars bright in all quadrants as far as the eye could see.

The light was located slightly East of the North star on a course slightly East of South at an elevation of approximately 30°. As I located the object, it formed into a cigar shape of aura with the bright light at the Northern end implying an aircraft landing light shining through a light haze so that I considered this might be a passing aircraft signalling in an accustomed manner and listened for the motors.

Within a minute I realized this to be incorrect so endeavoured to obtain as accurate an impression as possible.

At 01⁰⁹ Z direction changed to South East and was maintained until 01.12 at which time direction changed again to North East in which direction the object became too dim to discern by 01.15 Z.

During the observation the object changed position approximately 30° of horizontal angle while remaining at almost the same elevation. Light intensity was that of a 2nd. magnitude star dimming only as it disappeared in the East.

Strange object seen moving in the sky

A resident of Red Hills told the Gleaner last night that a bright object looking like a Sputnik or a Flying Saucer with a long tail added, was seen moving across the sky from North-West to South-Southeast last night.

Contacted, Dr. E. C. Melville, president of the Jamaica Astronomical Society, said he had viewed the object through his telescope and to him it appeared to be three bright objects looking like stars, but in formation. They might have been three jet planes, or guided missiles, he said.

BUFF BAY, Pd., July 9 (From our correspondent): An object believed to be a satellite was seen here by many people at 8.20 p.m. It travelled in a north easterly direction and was visible for over a minute.

TO WHOM IT MAY CONCERN.

On July 9th. at approximately six minutes after eight in the evening, I observed what at first - for a few seconds only - appeared to be a falling star. On looking directly at the lighted object, it appeared to be a star, the tail by this time had disappeared. After watching for approximately one minute, I drew the attention of Captain Beckett to the object, which at this time appeared as an oval shaped glow of lighted area as if strong lights had been turned on and appeared to be at the sides and rear of the star-like central point. The object this time was moving almost due South. In the course of seven minutes approximately, the course was changed as in a large crescent changing course through almost a full 180°. At various times through this pattern, it appeared as a large oval glow as a star and again as a combination of three stars, one central, brighter than the two trailing outside lights which appeared only briefly and occasionally. As it proceeded North and away from us, it disappeared in the distance. In appearance, it was at a tremendous height and appeared to twinkle as a star, during this whole time, there was no sound of any sort. 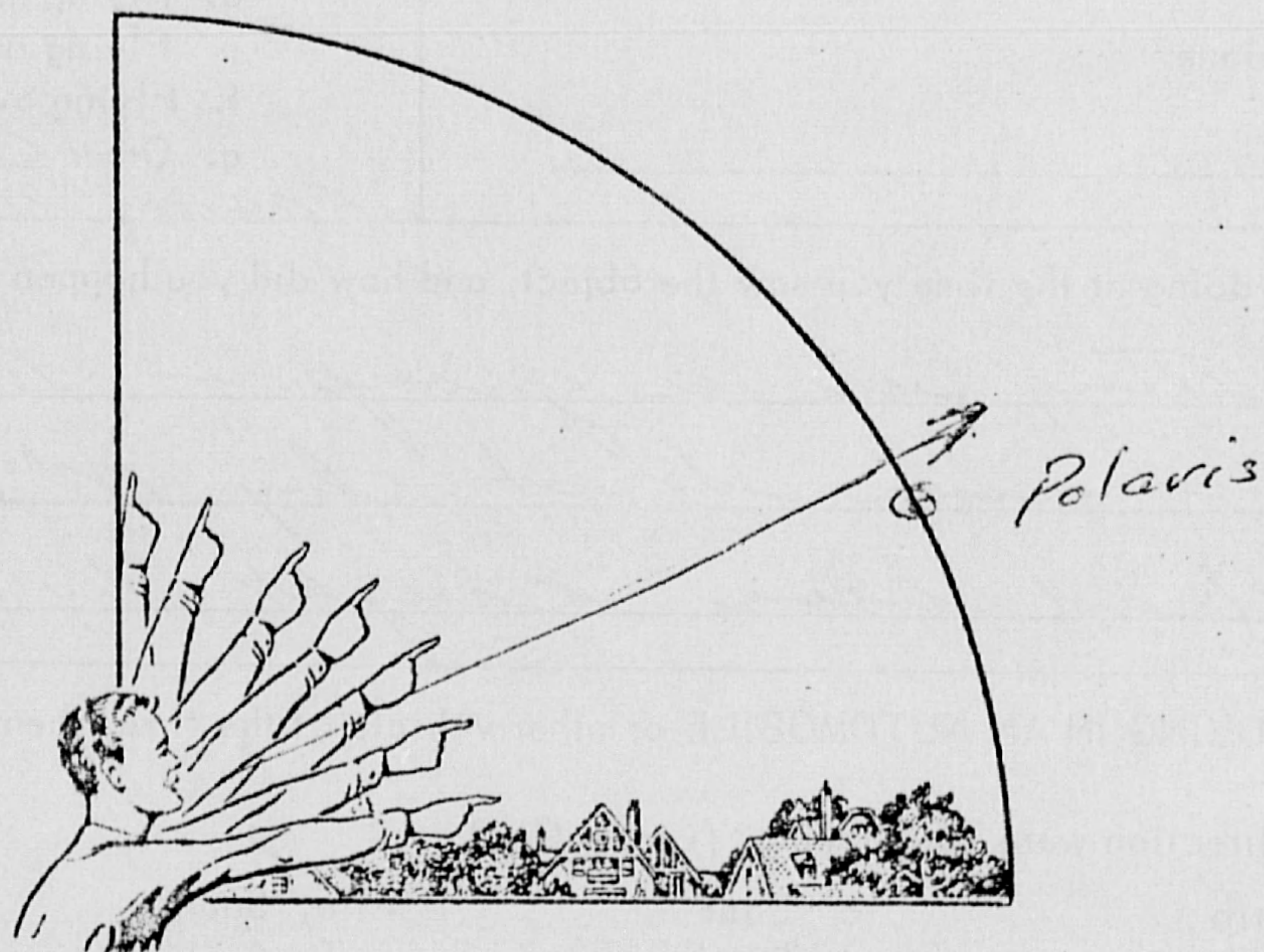

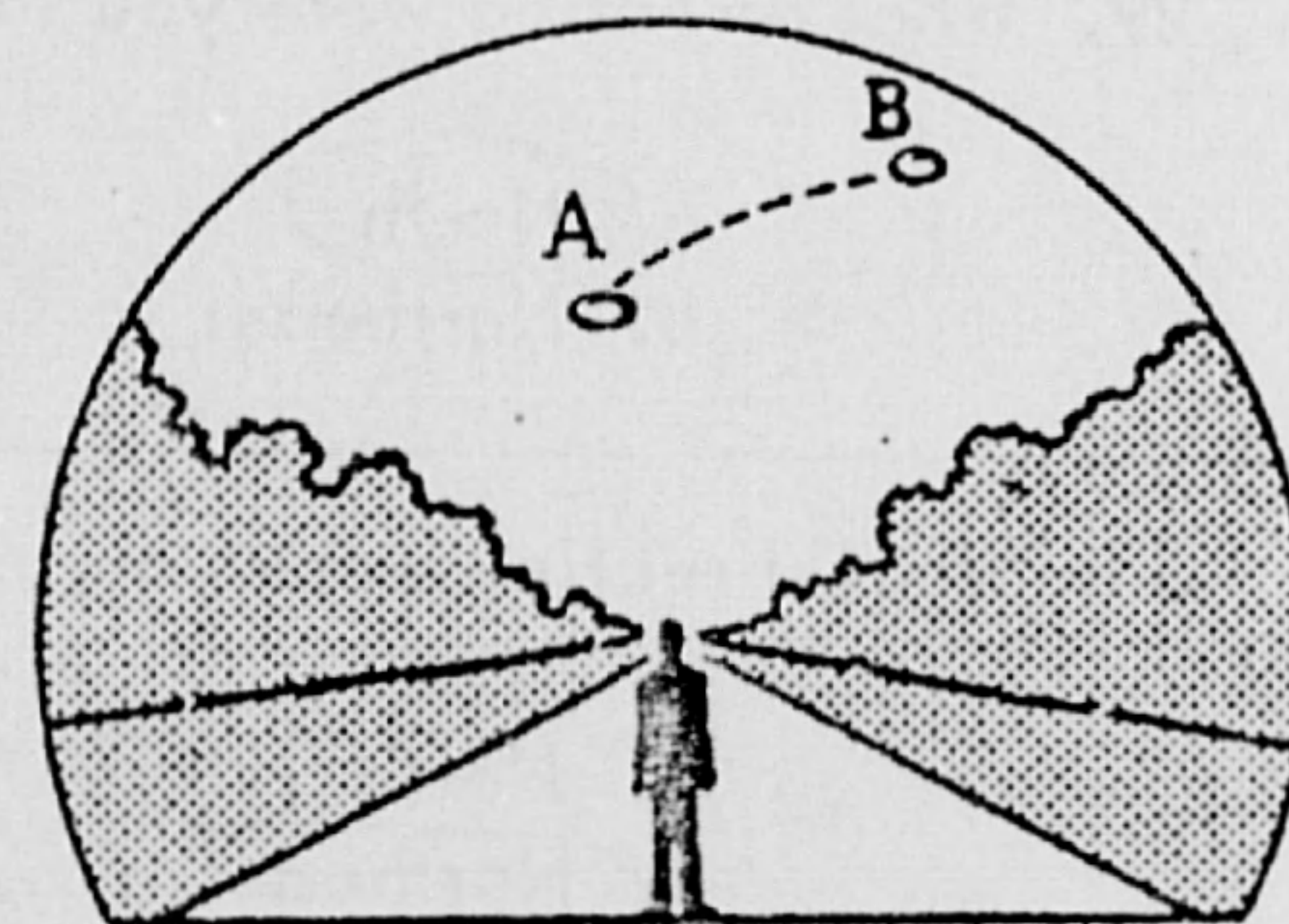
